## **SELECTMEN'S MEETING - December 13, 2010**

Correspondence was read and acted upon.

The Selectmen reviewed the following septic plans:
Guy & Pamela Trag Map 203 Lot 28.1 amended
Mary Porter Red House Realty Map 230 Lot 21.3

The Selectmen approved the use of the Sugar Hill Meetinghouse by the Profile School French Program on March 12, 2011 for a benefit concert.

The Selectmen approved the demolition of a shed on the Randall Kunz property located on Map 218, Lot 56. 1495 Route 117.

The Selectmen received notification the Alex Aaron has appealed the ZBA decision of November 9, 2010. The Zoning Board of Adjustment will meet on Tuesday, December 21, 2010 to review the motion for a rehearing and to either grant or deny the request.

CHIEF WENTWORTH met with the Selectmen to update them on Police Department business. Chief Wentworth will be hiring a new part time officer beginning in January 2011. Chief Wentworth also discussed with the board the use of the Crapo Building for dog obedience training.

ROAD AGENT DOUGLAS GLOVER met with the board to discuss his budgets for this year and also 2011. The board reviewed the Highway Department Capital Reserve Funds and potential allotments for the 2011 warrant. Mr. Glover discussed the process whereby his pick- up truck is handed down to the Building & Grounds department every three years and he does not get the value for a trade when he purchases a new vehicle for the highway department. The board discussed the merging of the two departments in the future which would help to clarify this problem. Mr. Glover discussed the leave policy and unused hours that he has.

DAVID THURSTON met with the Board to update them on questions that had been asked of him as Vice Chair of the Planning Board. The property in question on Sunset Hill Road has a common drive for three parcels. The board agreed that any questions should be made to the Sugar Hill Planning Board at their January 2011 meeting. Mr. Thurston then submitted his application for a building permit for an addition to his barn. A 20 x 45 pole barn.

The Selectmen approved an addition to the barn at the home of David and Coralie Thurston on Map 218, Lot 59. 1553 Route 117.

MR. BIELEFIELD made a motion to accept the minutes of December 6, 2010, seconded by MR. STRASSER. The motion was approved unanimously.
