

SELECTMEN'S MEETING – February 22, 2010

Correspondence was read and acted upon.

The Selectmen signed the 2010 Town Meeting Warrant and the MS 6 Budget of the Town. The warrant is posted at the Sugar Hill Meeting House, the Carolina Crapo Building and will be available on the website. www.sugarhillnh.org

The Selectmen received a \$100.00 donation from the North Country Chamber Players.

The Selectmen signed an Intent to Cut Wood or Timber for William Norton, Map 218, Lot 38.

CHIEF WENTWORTH met with the Board on Police Department business. Chief Wentworth advised the board of a new agreement with Littleton Pet Center with a \$20.00 per day charge. The center is used when stray dogs are picked up in Town. Every effort is made to find the owner prior to utilizing the center. Chief Wentworth discussed a new scam that an elderly couple in Sugar Hill were the victims of. The caller pretends that the grandchild needs money and requests money to be wired. The Chief notified the Selectmen that two residents were involved in an altercation in Littleton.

The Selectmen approved the use of the Sugar Hill Meeting House by the North Country Home Health & Hospice for their annual volunteer appreciation dinner on April 22, 2010.

The Selectmen will send the assessing contract from Trumbull Associates to the Department of Revenue for review.

MR. DE MAYO asked the board if they would put the budget and revenue hand outs from the budget hearing up on the website. The Selectmen responded that they will be putting up the warrant and that has more information. Also that Town Reports will be available next week. It was noted that unless you attend the hearing the information on the hand outs is not that clear. The revenue page especially is estimated and done conservatively by the board.

The Town Moderator James Snyder will be in on March 1, 2010 to discuss the upcoming warrant with the Board of Selectmen.

MR. BIELEFIELD made a motion to accept the minutes of February 8, 2010, seconded by MR. STRASSER. The motion was approved unanimously.

MS. CONNORS made a motion to enter non-public session at 6:15PM to discuss welfare applications and police personnel, seconded by MR. STRASSER.
