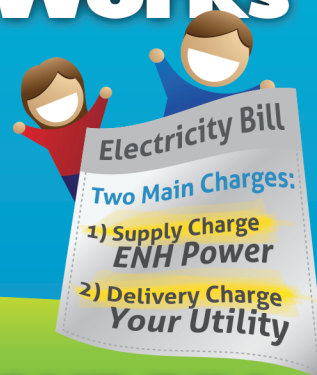

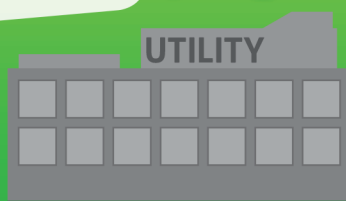
POWER SUPPLY
