## SELECTMEN'S MEETING - March 21, 2016

Correspondence was read and acted upon.

The board reviewed a draft personnel policy and made changes accordingly. Jennifer will edit and complete the policy for a final review.

The board reviewed the transfer station agreement as provided by legal counsel. Changes were made and Jennifer will locate the original warrant article from the Franconia Town Report in 1998 setting up the special revenue fund.

The board signed the State of NH Surplus Property Contract.

The board received notification from North Country Council that the Hazardous Mitigation Plan will expire next year. The new round of grants from Homeland Security will allow the North Country Council to act on our behalf for the renewal process. Jennifer will notify the State that we wish to work with North Country Council.

The board approved the use of the Sugar Hill Meetinghouse by the Lafayette School 6<sup>th</sup> Grade Parents group for a graduation potluck supper on June 14, 2016.

MARGO CONNORS updated the board on the SEC Hearing last Monday. The board received the Order on Petitions to Intervene. Sugar Hill is in Municipal Group 2 with Franconia, Easton, Woodstock, and Plymouth as a single party. The Sugar Hill Historical Museum is under Non-Governmental Organizations #3-c: along with NH Preservation Alliance and National Trust for Historic Preservation, and the North Country Scenic Byways Council as a single party. The Attorney was concerned with grouping Towns will legal counsel with those that do not have representation.

MR. STRASSER made a motion to appoint MR. BIELEFIELD the chairman of the board, seconded by MS. CONNORS. The motion passed.

The board approved a request from the Road Agent Doug Glover to loan a piece of equipment to the Franconia Highway Department.
