The board reviewed the Equalization 95.9 and Median 98.7 ratios as provided by the DRA for 2019.

CHIEF CLARK updated the board on the emergency management policies in place. Littleton Regional Healthcare has a number where you can call with medical questions and speak with medical personnel. 603-575.6400 The Police Department has been provided with masks and gloves. The policies for Emergency calls have been updated and Chief Clark has been in communication with Littleton Fire/EMS. Chief Clark maintains contact with both the State and Littleton Regional Healthcare. The hospital has 81 beds and the National Guard is setting up additional beds if needed. The resident list has been updated for those that might need assistance. All will be called this week for a wellness check.
