**Specific Statutory Reason** cited as foundation for the nonpublic session:

RSA 91-A:3, II. (a) The dismissal, promotion, or compensation of any public employee or the disciplining of such employee, or the investigation of any charges against him or her, unless the employee affected (1) has a right to a meeting and (2) requests that the meeting be open, in which case the request shall be granted. (c) Matters which, if discussed in public, would likely affect adversely the reputation of any person, other than a member of the public body itself, unless such person requests an open meeting. This exemption shall extend to any application for assistance or tax abatement or waiver of a fee, fine, or other levy, if based on inability to pay or poverty of the applicant.

The board discussed a letter from Chief Clark in regard to the Lally Building Permit for 112 Streeter Pond Drive. Chief Clark has multiple concerns and his letter will be sent on to Mr. Lally. The board reviewed the plans which appear to be greater than the 20% allowed by zoning and that they have added a front porch that does not meet setbacks. A letter will be sent along with Chief Clark's letter.

Jennifer updated the board on the Labor Department Safety Inspection. All infractions have been corrected and a new inspection will be scheduled next week.

Chief Clark notified the board of HB111 relative to eliminating municipal immunities and asked that they contact the town representatives and state senator.

The board discussed appointments for the Conservation Commission and the Planning Board. Any interested resident should contact the town office.

The board agreed to write a letter of support to NHDES on behalf of Pemi-Baker Solid Waste District for a Household Hazardous Waste Collection Reimbursement Grant.

MS. CONNORS had a draft of the Solar letter to be reviewed. Also a new solar information packet was submitted and will be available on the town website.

MS. CONNORS made a motion to approve the meeting minutes of March 15, 2021, seconded by MR. STRASSER. The motion passed unanimously.
