SELECTMEN'S MEETING – July 12, 2021

The board met with Eric Rasmussen to discuss and approve his building permit application for 930 Route 117. Work has been done in the basement and there will be a 21'x9'x8' addition. Eric needs to submit a plumber name and license number. In addition, the board approved a septic plan as submitted by Presby Construction for the property. This will move the septic back to the house side of the road. Map 219. Lot 6

Jennifer asked the board on behalf on Peter Carbonneau if the maple trees in front of the Meetinghouse could be assessed as several are dying and or dead. Margo will ask Mike Cavanaugh to look at the health of the trees so that a decision can be made.

MR. ELLMS mentioned that there are some dead trees on the Crane Hill Road/Blake Road corner that should be taken down. Jennifer will follow with Doug as to location and if in the town right of way.

The Police Department received a noise complaint from Christine Mealy in regard to the town dump trucks hauling material and dumping in her neighborhood. She felt that it has gone on for a long time and is disruptive to people living in the area. The board will discuss with road Agent Doug Glover the duration of the ditching and any alternatives.

MS. CONNORS will follow up with Spectrum as several residents on Pearl Lake Road were told that even with them paying, they would not extend service down the road.

LARRY SAWYER had some recommendation for signage at Coffin Pond to include no overnight camping and carry in, carry out. Appears people are laving trash and not cleaning up after their dogs. Chris Ellms will discuss at the SH Conservation Commission meeting this Thursday.

BOB MANCINI is looking into who if anyone is doing work on the dam at Coffin Pond this summer. The SHCC would like to have work done on the inlet but would like to work with whomever is doing the dam at the same time.

603 Solar submitted a building permit for the Town Garage Project. The board signed off and will ask Chief Clark to sign off as well.

The board approved a driveway permit for Tucker/Boyd Map 230, Lot 20.2

The board received thank you acknowledgement from the American Red Cross for monies that were raised at the May town meeting..

MR. BIELEFIELD made a motion to approve the minutes of July 5, 2021 seconded by MR. ELLMS. The motion passed unanimously.
