Report on Stone Right to Inter

The committee acknowledged that a letter was sent to K. Stone regarding the Right to Inter in the Burt family lot.

Landscaping

Annette estimates that it would cost \$900 to prepare and install a flower bed near the granite bench. Funding this project is a possibility for 2022. Five shrubs & 14 perennials would be about \$400, the remaining \$500 would be labor.

Burial Rates

The committee reviewed a comparison of what Sugar Hill and other towns in NH charge for a burial. It was noted that most towns charge extra for weekend or after-hours burials. A cost analysis would be helpful to determine whether our costs are covered by the current rates. Members of the committee will meet with the selectmen to gather information about burial costs and revenue sources. Peter will also estimate his time for full and cremation burials, which will help the committee understand the work involved. Questions to consider:

- Do we need to increase the rates and if so, why
- Do we need to charge more for weekends and if so, why
- Could we offer no-fee burials for veterans?
- Rules and Regulations
