

## SELECTMEN'S MEETING – October 18, 2021

Correspondence was read and acted upon.

The board will meet with Franconia and Easton Select Boards next week at 6:00pm to discuss the Transfer Station and the Tri Town Recreation Budgets.

The board reviewed a septic plan for the Connors property located on Map 214, Lot 23 pending a lot line adjustment.

The board approved building permits for: Gary Way Map 214, Lot 6 – Tool Shed  
Chris Laganos Map 211, Lot 5 Detached Garage

The board submitted a letter to the NH Liquor Commission in regard to a license for the Sugar Hill Inn.

The board will meet with ACT in November to discuss parking areas at Dyke Road, Pearl Lake Road and at the Cooley Jericho Town Forest. The current gate will come down so that the landowner may access his property.

The Healthtrust rates for 2022 are down Health 8.1%. Dental 1.5%

MR. BIELEFIELD made a motion to appoint Charles Wolcott to replace Justin Kline on the Cooley Jericho Forest Committee, seconded by Margo Connors. The motion passed unanimously.

Jennifer shared the Cemetery List of projects with Doug to see which required the highway department assistance.

Jennifer advised the board that there was damage done to Gary Young's property on South Road by the company delivering the solar equipment. There will be a claim filed with the transporters insurance to fix the yard.

MR. GLOVER will work on the Coffin Pond back up tomorrow. Margo suggested it would be good to have Town Forest and Coffin Pond groups to monitor activity at both locations.

Jennifer received a letter stating that the new wood boiler is eligible for a 26% tax credit and will share with the auditor.

The board sent a letter to Charter communications Mr. Maher in response to his reaching out to municipalities.

The board is still concerned with the sidewalk in front of Harman's. Jennifer will contact NHDOT to follow up as we have not heard from them.

MR. ELLMS made a motion to approve the minutes of September 27, 2021 seconded by MS. CONNORS. The motion passed unanimously.

MR. ELLMS made a motion to approve the minutes of October 4, 2021 seconded by MR. BIELEFIELD. The motion passed unanimously.
