

SELECTMEN'S MEETING – November 20, 2017

Correspondence was read and acted upon.

The board reviewed the following Amended Septic Plans:

The board reviewed a building permit for Gerry and Jan Strathmann on Map 230, Lot 13. The setbacks were incorrect and will contact the builder for clarification.

CHERYL WIGGETT from the Lisbon Stump Jumpers was requesting formal permission for the club to travel over three parcels. The board asked Road Agent Glover to review as well and the permission was granted.

The Town Clerk Lissa Boissonneault will be closed from the 16th of January to the 6th of February. The Franconia Town Clerk Carol Wills will do Sugar Hill registrations.

The board received an abatement for Scott Gilbert Map 202, Lot 18.

The board asked Chief Clark if the paperwork for the Hazardous Mitigation Grant reimbursement had been submitted. He will get the paperwork in so that we can hopefully have reimbursement before the year is out.

DOUG GLOVER discussed the continuing clean up of the roads from the October 30th storm. Currently the department is only cutting downed trees that are in the Town right of way. Because of the July and October storms the department has been repairing roads and has not done any routine maintenance. ALLAN CLARK (via telephone) advised the board of the ridiculous amount of detail that FEMA is requesting. He does not anticipate any FEMA funding until 2018. To date there have been 26 different FEMA officials visit the town since the July storm.

The board approved a Veterans Tax Credit.

The Board received thank you notes from Hadley Road residents and also Lafayette School thanking the Police and Fire Departments for assistance.

The board signed additional thank you notes for Northern Pass Defense Fund donations.

The board received the Workers Compensation and Property Liability costs from Primex

CHIEF CLARK discussed with the board the Calnex agreement with the Town and the intent to raise the cost for 2018. The Town of Sugar Hill is dependent on the contract that Calnex has with the Town of Littleton. The town will have to wait and see what happens with the request for an increase in Littleton.

MR. STRASSER made a motion to approve the minutes of November 13, 2017 meeting seconded by MS. CONNORS. The motion passed unanimously.

With no more business before the Board, MR. STRASSER made a motion to adjourn; seconded by MS. CONNORS the meeting was adjourned at 7:10 PM. The next regular scheduled meeting will be on Monday November 27, 2017 at the Carolina Crapo Building at 5:30 pm.
