Jennifer passed on a message from Luther Kinney thanking Road Agent Glover for the work that was done to prevent further damage from the ice jam this spring.

KATHY JABLONSKI met with the board in her position of Cemetery Trustee. The trustees have worked very hard to update the rules and regulations and also the bylaws for the Sugar Hill cemeteries. In addition, the trustees have put together a three-part process for those buying lots including, right to interment, interment designations and formal letter for owner's record. These forms will bring the trustees up to date and also meet all legal requirements of the State of NH. The trustees have been meeting monthly and will continue to do so on the second Thursday of the month at 4:30pm at the Crapo Building. The select Board is very appreciative of all the work the trustees have done.

JASON TORS met with the board in his position as Library Trustee to submit two prospects to fill the recently vacated trustee position. After general discussion with the board MS. CONNORS made a motion to appoint Alice Claflin to fill out the one-year term until Town Meeting 202, seconded by MR. BIELEFIELD. The motion passed unanimously.

MR. ELLMS, made a motion to nominate Margo Connors as chairperson for the board, seconded by MR. BIELEFIELD. The motion passed with Margo abstaining.

MR. BIELEFIELD made a motion to approve the minutes of March 28, 2022 seconded by MS. CONNORS. The motion passed unanimously.

With no more business before the Board MS. CONNORS made a motion to adjourn, seconded by MR. BIELEFIELD the meeting was adjourned at 6:30 PM. The next regular scheduled meeting is Monday April 11, 2022 at the Carolina Crapo Building at 5:00 pm.
