The board reviewed the information provided by Assessor Gary Fournier in regard to the DeMayo – BTLA case. The board will write a letter asking for the case to be dismissed.

The board will send a letter to NHDOT Engineer Philip Beaulieu in regard to the road in front of Harmans and the need for a crosswalk location to be agreed upon. Last year DOT was supposed to send a representative from the sidewalk bureau and never did.
