Correspondence was read and acted upon.

The board will not meet on Monday, May 29th in observance of the Memorial Day Holiday.

CHIEF HO-SING-LOY met with the board on police department business. The board reviewed the residents concerns from last meeting and the Chief will implement some of the suggestions and bring out the speed trailer. Chief Ho-Sing-Loy and Jennifer previously attended the cyber security training at PRIMEX and the town plan is almost complete. The board heard from Eric Duggs, USDA-NRCS regarding the erosion problem at the DeMayo residence on Easton Road. Jennifer will confirm a date with all parties in June.

The town received a refund of \$4,629.30 from the solar installation that will go to the general fund. This is the amount from when the solar started in December of 2021.

MARGO CONNORS gave an update on Tri Town Transfer Station. The new hauling situation has gone well with good communications with Normandeau Trucking. Needed to repair a door on one of the containers for \$750.00. The plastic recycling will be changing as only 1& 2 can now be recycled.
