There will be another hearing for Community Power with Franconia and Bethlehem at the Profile School Library on December 14th at 6:00pm. The town will also hold a community power hearing on Monday December 18th at 6:00pm at the Crapo Building. The board will include community power information with the tax bill mailing.

CHIEF ALLAN CLARK – Presented the Medical Resource Hospital Agreement and Chief Clark wanted it signed in a timely manner as the town license will expire at the end of this month. The board signed the signature page. Chief Clark noted that funds were received from the dissolution of the Franconia Life Squad in the amount of \$5200.00 to use for supplies. He believes there will be 41-45 calls before the end of the year and most are residents. Most calls have a three-person response.
