Mr. De Mayo also asked about costs of the Building & Grounds truck and if comes in lower it was explained that the lower cost is what will be spent over four years, Mr. De Mayo also questioned the compost cost that will be added to the Transfer Budget this year and felt it was an unfair tax for those that do not benefit from the system. Margo noted that entire cost for Tri Town would be \$10.00/week \$520.00 a year. The Sugar Hill portion would be around \$150.00 and perhaps a resident would donate those funds.
