## **Minor Subdivision**

## **Conceptual Hearing**

Russell Tanguay presented before the Board to discuss a possible subdivision on his current property on Hidden Acres Drive. The lot is 6.66 acres and he is contemplating splitting the lot into 2 lots with the intent to build a new home for himself on the new lot and sell existing home. Mr. Tanguay needs consent from the developer in order to subdivide the property. It was noted that he would need shoreline permits, test pits for both lots, 200' of road frontage for each lot, and a letter in writing from the developer stating approval to subdivide. Mr. Tanguay stated he would speak to the developer and let the Board know if he was going to proceed.

## **Subdivision Regulations Review**

Tara met with the Board via Zoom to continue discussion on Land Subdivision Regulations. She reviewed changes that were made after the March meeting. Board members will review the checklists for discussion at the May meeting.

## Audit of Site Plan Regulations
