All Veteran forms, elderly and not profit organizations have returned their forms. The Current Use forms are coming in and taking an enormous amount of time to process.

Chief Ho-Sing-Loy, Road Agent Glover and Jennifer will meet with FEMA and the State personnel for the Recovery Scoping Meeting on Tuesday.

The board has responded with letters in regards to HB 1291 regarding accessory units and HB 1124 regarding conflict of interests in town/school offices.

The board would like to set up a tri town meeting with Franconia and Easton to discuss mutual interests including Tri Town Transfer and Recreation.

The board will set June 3^{rd} at 3:30 pm to look at the areas in town that will be affected by Eversource pole replacements.

BRENDA ALDRICH met with the board to discuss parking issues in front of Harman's and to discuss Lupine parking policies. Brenda hoped there will not be too many signs that will convey negativity. She has issues with handicap people being able to access the store. She asks that people drop the person who needs assistance at the door and then park in back. Brenda would like to relocate one of the signs in front of the store. Regarding Sunset Hill Road, we believe only on side will be marked no parking. Perhaps the Chamber of Commerce could formulate a map that could be given to people marking lupine fields.

TREVOR PRESBY was not able to attend and had called and cancelled and will be rescheduled.

Public comment: The first turtle sighting on Route 117 was further up the road above Polly's and not down at the Bickford Hill intersection. The State has said they would put some game cameras in the new culvert but that did not happen.
